4. Balance must be paid in full 2 weeks in advance of the scheduled day.
5. Insurance certificate must be presented no later than 2 weeks in advance of the scheduled day.

Rental options include the following:

For One or Two Day Events

- 1 Use of the Chantilly the DAY BEFORE your wedding, reception or party from 9 am - 7 pm (10 pm if having rehearsal dinner) for delivery and set up of tables, chairs and decorating ONLY.
2. The day of your wedding, reception or party from 9 am - 12 midnight. \$100.00 per hour past midnight. All trash must be removed from the Chantilly the night of the party.
3. The day after to clean up: 10:00 am - 12:00 pm All trash must be removed from premises.

For One Day Events

- 1 One day rental 1s from 8:00 am - 12 midnight ONLY. \$75.00 per hour past midnight.
2. Deliveries, set-up and clean up must be done the DAY OF THE EVENT in the allotted time. **\*\*Exceptions** According to other events scheduled, you may be allowed DELIVERIES ONLY the day before for an ADDITIONAL FEE of \$100.00. Anything more would be considered a two day rental for \$2500.00.

The Rental Deposit is non-refundable and no rescheduling on account of rain.

NO WEAPONS ALLOWED ON THE PROPERTY!

NO DATE WILL BE SAVED UNTIL A DEPOSIT IS RECEIVED

ALL PRICES INCLUDE ONE VISIT TO THE BARN FOR MEASURING ETC.
